Miniature Horses do not exceed 34"

Small Horses should not exceed 38"

Little Horses should not exceed 42"

Miniature Ponies should not exceed 34.25"

Small ponies should not exceed 42"



All Leads need to be Captured. **NO LIVE CHAINS** Stallions/colts over 2 years of actual age will not be shown by persons under the age of 18. No youth 12 years and under may show/handle a stallion/colt at any age. With show organisers approval, youths over 12 may show colts up to 1 year old, and youths 13 and over may show colts up to 2 years of age. Performance Classes – exhibits must be at least 1 year (actual age) to compete in any performance class. Junior exhibits are 3 years and under at the 1st August Senior exhibits are 4 years and over at 1st August Youth exhibitors under 9 Years must have an adult in the ring at all times. All Exhibitors must be a Financial member to compete to Horses must be registered to compete (Can be with any society) It is preferred that make up is kept to a minimum. Horses are to be presented clean and well groomed. Horses are to be sound and may be excused from ring if they are not. Exhibits show at their own risk. No responsibility will be taken by AMR or its organisers, by entering you are agreeing this rule. All equipment (including halters, leads, Bridles etc must be in good working order) There may be random Drug testing and by entering your horse you agree to this. Should a protest be made, it needs to be within 30 minutes of the class via a written complaint and a fee of \$50 is payable (which will be returned if the protest is found correct) The judge can ask a competitor to leave the ring if a horse/pony is unruly. All entries are to be pre entered. Committee reserve the right to refuse any entry at any time. No bullying or intimidating will be tolerated AT ALL. If you are found to be doing so you will be asked to leave, and all entries will be forfeited. Please ensure you have read ALL rules & regulations. AMR General, Show & Performance rules will be adhered to. A Copy will be available at the event for you to view. No refunds will be issued. If the event is stopped due to weather a credit will be issued for use at future AMR NORTHERN NSW Shows. Entrant Number Cards can be displayed on the Back, Arm or Front of jacket. No lower than hip Height. These will be provided with your Catalogue on the Saturday. **By entering the show, you agree to all rules set out.**

ALL HORSES MUST HAVE UP TO DATE MINIATURE HORSE PAPERS – can be any society except for the amr reg classes

WE RESERVE THE RIGHT TO REFUSE/DENY ANY ENTRIES – NO EXCEPTION TO THIS

UNCLIPPED MEANS THE HORSE HAS NOT BEEN CLIPPED IN THE LAST FEW MONTHS – YOU CAN CLIP THE BRIDLE PATH, CHIN HAIRS AND FEATHERS TO TIDY UP. YOU CAN ALSO ENTER THE OPEN AS WELL AS UNCLIPPED IF YOU WISH.

Australian Miniature Horse & Pony Registry and (Name of Show) ...**AMR NSW YOUNGSTOCK & VETERAN**. (together the Suppliers) advise that participation (including passive participation) in animal handling at a show contains elements of risk, both obvious and inherent. That handling of animals is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

1 By signing this waiver I acknowledge that: 11.1 participation in animal handling is a recreational service for the purposes of section 139A of the Competition and Consumer Act (Cth) 2010, and also a recreational activity for the purposes of Section 19 of the Civil Liability Act (2002); 11.2 participation in animal handling is a hazardous activity and may result in injury, loss, damage or death to me; 11.3 participation in animal handling requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the events; 11.4 animals can act in sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises; 11.5 animal showing events may be held in close proximity to loud and unfamiliar noises which can frighten animals. 11.6 if the event is held outdoors, there are risks to me as a result of weather conditions, including extreme hot or cold weather, rain or wind; 11.7 insects or other animals may cause animals to become frightened and act in an unpredictable way; 11.8 there is inherent in events involving the handling of animals the risk of suffering

injury including injuries caused by animals; and 11.9 I use the facilities supplied for the event entirely at my own risk; as I find them and with the prior acceptance of the risk of possible danger to me.

12 If I suffer injury, loss or damage (Loss) while participating in an animal handling event, I will not hold the Suppliers, their employees or agents legally responsible for any Loss I suffer.
